## MINUTES OF THE REGULAR MEETING OF THE BOARD OF COMMISSIONERS OF THE FARGO PARK DISTRICT OF JANUARY 9, 2024

The regular monthly meeting of the Board of Commissioners of the Park District of the City of Fargo was held on Tuesday, January 9, 2024, at 5:30 p.m. at the Fargo Park District office at 701 Main Avenue, Fargo, North Dakota and via Restream. Present at the meeting were Commissioners Dawn Morgan, Aaron Hill, Jerry Rostad and Vicki Dawson. Also present were: Dave Bietz, Susan Faus, Carolyn Boutain, Broc Lietz, and Jeffrey Gunkelman.

#### **Approval of Amended Agenda**

Commissioner Vicki Dawson moved and Commissioner Jerry Rostad seconded a motion to approve the amended agenda. Upon call of the roll, the motion passed unanimously.

#### **Approval of Amended Consent Agenda**

Commissioner Vicki Dawson moved and Commissioner Jerry Rostad seconded a motion to approve the following actions on the consent agenda:

#### 2024 Park Maintenance Equipment Bids

Dave Bietz presented this matter. The 2024 equipment bids were received and opened on Tuesday, December 13, 2023.

Commissioner Jerry Rostad moved and Commissioner Dawn Morgan seconded the motion to approve the following bids: bid package #1 to MTI Distributing Inc. with a bid award in the amount of \$609,161.00 for the 2024 Pack District Park Maintenance Equipment; bid award to Acme Electric in the amount of \$155,631.00 for Kubota 130 HP 4WD Tractor w/Normand Snow Blower, and \$1,815.00 alternate for a side discharge for a total amount of \$157,446.01, and a Kubota L5460HST Tractor in the bid amount of \$42,450.00; and a bid award in the amount of \$64,999.00 to Butler Machinery for a HitchDoc HDS 9200 Work Tool. Upon call of the roll, the motion passed unanimously.

### MEMORANDUM

RE: Consent Agenda Item (c) - Memorandum of Understanding Agreement with the

City of Fargo for Easements and Restoration of Parking Surface at Trollwood

The City of Fargo has requested easements to assemble and store construction related materials upon a portion of the parking surface located at 103 and 113 36<sup>th</sup> Avenue North and 3672 Elm Street North, which is known as Trollwood Park, during construction of the lift station. With this Memorandum of Understanding (MOU) the Park District also agrees that it will grant unto City of Fargo a permanent easement allowing construction and maintenance of the storm sewer lift station and underground public utilities.

In exchange for the above-described easements, City of Fargo hereby agrees to replace the impacted parking surface located at 103 and 111 36<sup>th</sup> Avenue North and 3672 Elm Street North at Trollwood Park. City of Fargo will replace the impacted parking surface as soon as reasonably practicable after completion of construction of the storm sewer lift station but agrees to complete the repaving by no later than September 1, 2025. City of Fargo agrees the parking surface will be replaced with six (6) inches of asphalt with an eight (8) inch base to its existing surface area and to the same dimensions as the parking surface exists as of the date of this MOU.

The project will impact three trees, that the Park District Forestry Department will move and replant.

The construction project is anticipated to begin in the Spring of 2024 and be fully complete by September 1<sup>st</sup>, 2025. There will be continued access for park users to navigate around the construction area and there will be access to the west parking areas within the park.

At our expense, we have requested the remaining parking lot paving to be reconstruction as well as adding pedestrian access to be completed under city's project. The current parking lot is in moderate to poor condition. Currently this parking lot is not on a schedule for replacement as there are several other priorities within our parking lot repair list. The city's estimate to remove and replace this our portion of the project is \$148,114.50. The city's estimated expense is \$264,420.50 on the remaining areas of the parking lot. Staff recommends granting this easement as doing so will minimally impact our park use and we will get a new parking lot as a result.

Included in the packet are a site plan, the memo of understanding, engineers' opinion of probably cost, and the easements that are being requested.

It was recommended at the January 31, 2024, Facilities Committee Meeting to bring this to the full board on the Consent Agenda for consideration and approval.

## MEMORANDUM OF UNDERSTANDING REGARDING EASEMENTS AND RESTORATION OF PARKING SURFACE

This Memorandum of Understanding ("MOU" or "Agreement") is entered into between the City of Fargo, whose address is 225 4<sup>th</sup> Street North, Fargo, North Dakota 58102 ("Fargo"), and the Park District of the City of Fargo, whose address is 701 Main Avenue, Fargo, North Dakota 58103 (the "Park District").

- **WHEREAS**, North Dakota Century Code § 40-05.1-6 and Article 3 of Fargo's Home Rule Charter authorize Fargo to enter into contracts; and
- WHEREAS, North Dakota Century Code § 40-49-04 authorizes the Park District to enter into contracts; and
- **WHEREAS**, Fargo is planning to remove an existing lift station and also reconstruct and expand another storm sewer lift station and related appurtenances on the south side of Kandi Lane near Trollwood Park in 2024 and 2025; and
- WHEREAS, Fargo has a need to obtain a temporary construction easement from the Park District to assemble and store construction materials upon a portion of the parking surface and green space located near and within Trollwood Park; and
- **WHEREAS**, Fargo has a need to obtain easement(s) from the Park District to allow for storm sewer utilities, including the proposed storm sewer lift station; and
- **WHEREAS**, because the parking surface at Trollwood Park is near the end of its useful life, upon completion of construction of the storm sewer lift station, Fargo is willing to reconstruct certain areas of the impacted parking surface; and
- WHEREAS, even though a portion of the parking area will not be impacted by the proposed construction, the Park District desires and agrees to reimburse Fargo for additional desired parking lot improvements upon Fargo's completion of construction of the storm sewer lift station.
- **NOW THEREFORE**, in consideration of the mutual terms, covenants, conditions, and agreements contained herein, it is hereby agreed by and between the parties as follows:
- 1. <u>Easements</u>. The Park District hereby agrees to grant unto Fargo a temporary construction easement effective until November 1, 2025, or a later date as mutually agreed by the parties, allowing Fargo to assemble and store construction related materials upon a portion of the parking surface and green space located at 103 and 113 36<sup>th</sup> Avenue North and 3672 Elm Street North, which is known as Trollwood Park, during construction of the lift station. The temporary easement area is more particularly described in Exhibit 1 attached hereto. The Park District also hereby agrees that it will grant unto Fargo a permanent easement allowing construction and installation of the storm sewer lift station and underground public utilities. The storm sewer and utility easement is more particularly described in Exhibit 2 attached hereto. The parties

acknowledge that demolition of one existing storm sewer lift station and reconstruction/expansion of the other lift station is anticipated through September 1, 2025.

- 2. Restoration of Parking Surface. In exchange for the above-described easements, Fargo hereby agrees to replace the parking surface located at 103 & 113 36th Avenue North at Trollwood Park. Fargo will replace the impacted parking surface as soon as reasonably practicable after completion of construction of the storm sewer lift station but agrees to complete the repaving by not later than September 1, 2025. Fargo agrees the parking surface will be replaced with six (6) inches of asphalt with an eight (8) inch base to its existing surface area and to the same dimensions as the parking surface exists as of the date of this MOU.
- 3. Park District Requested Improvements. The Park District has requested additional parking lot and pedestrian improvements, as depicted in Exhibit 3, to be completed under Fargo's project contract. The Park District hereby agrees to reimburse the associated costs directly to Fargo for the bid quantities based on the amounts outlined in the attached Exhibit 3. For the sake of clarity, the associated costs in Exhibit 3 are based upon an estimate. The Park District hereby agrees to reimburse Fargo the actual costs for the parking lot and pedestrian improvements.
- 4. <u>Construction</u>. Fargo shall be solely responsible for the construction of the storm sewer lift station and related appurtenances. Fargo shall also be responsible for the construction and maintenance of the underlying public utilities. Fargo hereby agrees to use all reasonable efforts to ensure Trollwood Park remains open to the public during construction.
- 5. <u>Park District General Maintenance</u>. Park District shall remain responsible for all futures repair and maintenance of its parking surface, including snow and debris removal, after Fargo completes replacement of the parking surface as required by this MOU.
- 6. <u>Release and Waiver</u>. To the extent allowed by law, Fargo shall hold the Park District and its agents, employees, and designees, harmless as a result of any injury or death and property damage or loss arising as a result of Fargo's use of the Park District parking surface for storage of construction materials, the construction and installation of the storm sewer lift station and related appurtenances.
- 7. <u>Notice</u>. Any notice or election required or permitted to be given or served by any party to this MOU upon any other will be deemed given or served in accordance with the provisions of this MOU if said notice or election is (a) delivered personally, or (b) mailed by United States certified mail, return receipt requested, postage prepaid, and in any case properly addressed as follows:

If to Fargo:

Park District of the City of Fargo ATTN: Finance Director 701 Main Avenue Fargo, ND 58103

Each such mailed notice or communication will be deemed to have been given on the date the same is deposited in the United States mail. Each such delivered notice or communication will be deemed to have been given upon the delivery. Any party may change its address for service of notice in the manner specified in this MOU.

- 8. <u>Time is of the Essence</u>. Time is of the essence of each provision of this MOU and of all the conditions thereof.
- 9. Entire Agreement. This MOU constitutes the entire and complete agreement between the parties with respect to the subject matter hereof and supersedes any prior oral or written agreements between the parties. It is expressly agreed that there are no verbal understandings or agreements which in any way change the terms, covenants and conditions set forth herein, and that no modification of this MOU and no waiver of any of its terms and conditions will be effective unless in writing and duly executed by the parties. It does not negate the parties' rights, duties and obligations under prior agreements related to the shared use path construction and operation, maintenance, and flood control system.
- 10. <u>Amendments</u>. No amendment, modification, or waiver of any condition, provision or term will be valid or of any effect unless made in writing signed by the party or parties to be bound, or a duly authorized representative, and specifying with particularity the extent and nature of such amendment, modification or waiver.
- 11. <u>No Forbearance</u>. The failure or delay of any party to insist on the performance of any of the terms of this MOU, or the waiver of any breach of any of the terms of this MOU, will not be construed as a waiver of those terms, and those terms will continue and remain in full force and effect as if no forbearance or waiver had occurred and will not affect the validity of this MOU, or the right to enforce each and every term of this MOU.
- 12. <u>Remedies</u>. Except as expressly and specifically stated otherwise, nothing herein will limit the remedies and rights of the parties under and pursuant to this MOU.
- 12. <u>Binding Effect</u>. All covenants, agreements, warranties and provisions of this MOU will be binding upon and inure to the benefit of the parties and their respective representatives, successors and assigns.
- 13. <u>Governing Law.</u> This MOU has been made and entered into under the laws of the State of North Dakota, and said laws will control its interpretation. Any litigation arising out of this MOU will be venued in State District Court in Cass County, North Dakota, and the parties waive any objection to venue or personal jurisdiction.

- 14. <u>Rules of Construction</u>. The parties acknowledge that they have had the opportunity to review this MOU, and that they have an equal bargaining position in this transaction. No rule of construction that would cause any ambiguity in any provision to be construed against the drafter of this document will be operative against any party to this MOU.
- 15. <u>Representation</u>. The parties, having been represented by counsel or having waived the right to counsel, have carefully read and understand the contents of this MOU, and agree they have not been influenced by any representations or statements made by any other parties.
- 16. <u>Headings</u>. Headings in this MOU are for convenience only and will not be used to interpret or construe its provisions.




## **Temporary Easement**







Staff is requesting permission to apply for a 2024 Garrison Diversion Conservancy District grant and an Outdoor Recreation Legacy Partnership (ORLP) grant that is funded through the Land and Water Conservation (LWCF Fund).

Garrison Diversion Conservancy District grants may be requested for outdoor recreational opportunities including but not limited to boat ramps and docks, picnic facilities, restroom, campgrounds, bathhouse, playground areas and bicycle and pedestrian trails. This is a matching grant for projects located within the Garrison Diversion boundaries that may be eligible to receive up to 25% of the non-federal share. The Recreation Committee meets biannually to consider grant applications. The deadline for this application is March 1, 2024. We are applying for this grant to assist with the replacement of the playground structure and plastic border at Rheault Farm.

The ORLP Grant was established by Congress in 2014 and is administered through the National Park Service. It is funded through the LWCF State and Local Assistance Program. ORLP is a nationally competitive grant program that delivers funding to urban areas, jurisdictions of at least 30,000 people with priority given to projects located in community areas as defined and identified in the Climate and Environmental Justice Screening Tool and areas lacking outdoor recreation opportunities. These awards will help underserved communities address outdoor recreation deficits by supporting objects in cities and densely populated urban areas that create new outdoor recreation spaces, reinvigorating existing parks, and form connections between people and the outdoors. The application deadline is April 30, 2024. We are applying for this grant to assist in the revitalization of Rabanus Park.

The Garrison Diversion Conservancy District grant and the Outdoor Recreation Legacy Partnership grant procedures require documentation that the Fargo Park Board of Commissioners approve of the project before consideration can be given to the park district for the grants.

With the Fargo Parks Sports Center opening this summer, the question has been raised both by staff as well potential users as to the availability of alcohol within the facility. As such, staff took the opportunity to review the policy as a whole.

The only updates staff are recommending are the listing of facilities within Schedule A and Schedule B. Changes to Schedule A are predominantly related to facility updates or a facility name change. Changes to Schedule B include updating the name of Southwest Youth Arena to Cornerstone Bank Arena and adding in the Fargo Parks Sports Center. The Sports Center includes both a full and limited permit option to give staff the flexibility to determine which is most appropriate based on the type of event requesting the permit. Staff's intention for the foreseeable future is to restrict alcohol permits to a designated space an event is renting that is inaccessible by other users of the building who are not a part of that particular event.

It was recommended at the January 31, 2024, Facilities Committee Meeting to bring this request to the full board on the consent agenda for consideration and approval.

## Park District of the City of Fargo Alcoholic Beverage Policy Approved: 06/08/21

#### **OVERVIEW**

The sale and/or consumption of alcoholic beverages on property owned or managed by the Park District is prohibited unless the sale and/or consumption is allowed by a duly issued permit from the Park District in accordance with this policy. Permits will be issued for designated indoor and outdoor facilities. For property managed by the Park District, the District will reasonably cooperate in working towards mutually agreeable arrangement whereby alcoholic beverages can be made available and/or sold at events (whether public or private) carried on at the property in accordance with all applicable laws and licensing requirements.

Any sale and/or consumption of alcoholic beverages on property owned or managed by the Park District without a permit is unlawful.

The consumption of alcoholic beverages is common at sporting events in Fargo. However, the consumption of alcoholic beverages should not detract from the programs and the use of facilities of the Park District. Consumption of alcoholic beverages on property owned or managed by the Park District should not be allowed when it will have a detrimental effect on the youth of Fargo. Revenue derived from permits will be used to defray the administrative costs of issuing the permits and any net revenue generated from Consumption Permits will be used for youth recreation programs. Any net revenue generated from Concession Agreements will be used for expenses of the event or facility where the sales were generated.

### I. <u>CONSUMPTION PERMITS.</u>

Permits to allow for the consumption of alcoholic beverages on property owned or managed by the Park District may be granted for specified locations and may limit the type of alcoholic beverages that may be consumed at the location under the issued Consumption Permit. Under most circumstances, the Consumption Permit will limit the consumption to alcoholic beverages allowed under the Limited Permit described in Article IV. A security deposit may be required. The Consumption Permit will allow individuals to bring to that location the allowed alcoholic beverages that have been purchased elsewhere. A Consumption Permit does not allow for any sale of alcoholic beverages.

Locations where Consumption Permits are allowed are listed on the attached Schedule A which is specifically incorporated by reference herein as part of the Alcohol Beverage Policy. Schedule A may be amended from time to time by the Board of Commissioners of the Park District.

With the approval of the Board of Commissioners, a consumption permit may be issued for other Park District properties, but only under such terms as the Board of Commissioners shall determine.

The fees and the requirements for a security deposit for a Consumption Permit will be established from time to time by the Board of Commissioners of the Park District.

### III. CONCESSION AGREEMENTS.

Permits for the sale of alcoholic beverages will be issued only in conjunction with a Concession Agreement with the Park District. The Concession Agreement between the applicant/seller and the Park District will provide, among other things:

- A) A statement of the concession fee (which may include a percentage of receipts formula) to be paid to the Park District.
- B) A description of the specific facility or property in or on which sales may take place.
- C) A designation of the term for which the permit is issued.
- D) A statement of the security required by the Park District, including procedures to ensure no sales to minors and that the beverages sold will not be taken from the designated facility or property.
- E) A description of the liquor liability and general liability insurance requirements to be maintained by the applicant/seller.
- F) The submission of the applicant/seller's intended advertising for approval by the Park District
- G) A security deposit, as required by the Park District, but in no case less than \$500.
- H) A statement as to whether or not the concession is exclusive.
- I) The applicant/seller's agreement to be responsible for all damage to persons or property caused by or related to its activities under the Concession Agreement, including repairs and clean-up, and its agreement to indemnify and hold the Park District harmless from claims arising out of use of property owned or managed by the Park District and the issuance of the permit.
- J) Seller must have all appropriate City and/or State licenses, and strictly comply with the requirements of such license, including having properly trained servers.

### IV. <u>LIMITED ALCOHOLIC BEVERAGE SALE PERMITS.</u>

A Limited Alcoholic Beverage Sale Permit ("Limited Permit"), together with the Concession Agreement required under Article III above, will allow the applicant/seller to sell beer, wine, products such as "hard" lemonade, seltzers and ciders, provided the same are sold in single serving cans or non-glass containers, or in the case of beer, in a keg monitored and serviced by the applicant/seller. The Limited Permit will be issued for a designated indoor facility or outdoor property owned or managed by the Park District. The sale of other spirits is not allowed under a Limited Permit.

Limited Permits may be issued for sales at the sites listed on Schedule B. The Limited Permit for property will be issued for a maximum of three (3) days. With the approval of the Board of Commissioners, a Sale Permit may be issued for other property owned or managed by the Park District but only under such terms as the Board of Commissioners shall determine.

Outdoor sales under a Limited Permit must be from a temporary tent or trailer or from a permanent concession building.

The following conditions apply to all Limited Permits:

- A) Seller must have all appropriate City and/or State licenses, and strictly comply with the requirements of such license, including having properly trained servers.
- B) Seller must have a Concession Agreement with the Park District.

The fee for Limited Permits will be established by the Board of Commissioners of the Park District from time to time.

### V. FULL ALCOHOLIC BEVERAGE SALE PERMITS.

A Full Alcoholic Beverage Sale Permit ("Full Permit"), together with the Concession Agreement required under Article III above, will allow the applicant/seller to sell all alcoholic beverages, including beer, wine and other spirits, unless specifically restricted by the Park District, in or on the designated property owned or managed by the Park District.

A Full Permit may be issued for alcoholic beverage sales at or on various Park District properties as determined by the Board of Commissioners or its designated staff. The Applicant/Seller shall make application to the Park District for a Full Permit and, if issued, shall fully comply with all terms and conditions set forth by the Park District for the issuance of the Full Permit. Outdoor sales must be from a temporary tent or trailer, a permanent concession building or, under limited circumstances, from a beverage cart designated for such purpose.

The following conditions apply to all Full Permits:

- A) Seller must have all appropriate City and/or State licenses, and strictly comply with the requirements of such license, including having properly trained servers.
- B) Seller must have a Concession Agreement with the Park District.

The fee for a Full Permit will be established by the Board of Commissioners from time to time. Alcoholic beverages, including beer, wine and other spirits, may be provided at other property owned or managed by the Park District and/or properties (e.g. the Edgewood

Golf Course and Clubhouse, the Rose Creek Golf Course and Clubhouse and the Osgood Golf Course) under separate agreements between the Park District and the concessionaire, whether that be a direct concession agreement or a leasing arrangement. Those agreements will be reviewed periodically by the Board of Commissioners and staff.

Accounting principles generally accepted in the United States of America (U.S. GAAP), as promulgated by the Governmental Accounting Standards Board (GASB), require that certain information be presented to supplement the basic financial statements. Such information, although not a part of the basic financial statements, is required by Governmental Accounting Standards Board, who considers it to be an essential part of financial reporting for placing the basic financial statements in an appropriate operational, economic, or historical context. As part of our engagement, we will apply certain limited procedures to the required supplementary information (RSI) in accordance with auditing standards generally accepted in the United States of America. These limited procedures will consist primarily of inquiries of management regarding their methods of measurement and presentation and comparing the information for consistency with management's responses to our inquiries. We will not express an opinion or provide any form of assurance on the RSI. The following RSI is required by accounting principles generally accepted in the United States of America. This RSI will be subjected to certain limited procedures but will not be audited:

- 1. Management's Discussion and Analysis
- 2. Schedule of Employer's Share of Net OPEB Liability and Related Ratios
- 3. Schedule of Changes in the Park District's OPEB Liability and Related Ratios
- 4. Schedule of Employer's Share of Net Pension Liability
- 5. Schedule of Employer's Contributions

Supplementary information other than RSI will accompany the Park District's basic financial statements. We will subject the following supplementary information to the auditing procedures applied in our audit of the basic financial statements and certain additional procedures, including comparing and reconciling the supplementary information to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and additional procedures in accordance with auditing standards generally accepted in the United States of America. We intend to provide an opinion on the following supplementary information in relation to the financial statements as a whole:

- 1. Combining Statement of Net Position Discretely Presented Component Units
- 2. Combining Statements of Revenues, Expenses and Changes in Net Position Discretely Presented Component Units
- 3. Balance Sheet Modified Accrual Basis Valley Senior Services
- 4. Statement of Revenues, Expenditures, and Changes in Fund Balance Budget and Actual Modified Accrual Basis Valley Senior Services

### **Schedule of Expenditures of Federal Awards**

We will subject the schedule of expenditures of federal awards to the auditing procedures applied in our audit of the basic financial statements and certain additional procedures, including comparing and reconciling the schedule to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and additional procedures in accordance with auditing standards generally accepted in the United States of America. We intend to provide an opinion on whether the schedule of expenditures of federal awards is presented fairly in all material respects in relation to the financial statements as a whole.

Also, the document we submit to you will include the following other additional information that will not be subjected to the auditing procedures applied in our audit of the financial statements:

1. Listing of Commissioners and Officers

#### **Data Collection Form**

Prior to the completion of our engagement, we will complete the sections of the Data Collection Form that are our responsibility. The form will summarize our audit findings, amounts and conclusions. It is management's responsibility to submit a reporting package including financial statements, schedule of expenditure of federal awards, summary schedule of prior audit findings and corrective action plan along with the Data Collection Form to the federal audit clearinghouse. The financial reporting package must be text searchable, unencrypted, and unlocked. Otherwise, the reporting package will not be accepted by the federal audit clearinghouse. We will assist you in the electronic submission and certification. You may request from us copies of our report for you to include with the reporting package submitted to pass-through entities.

The Data Collection Form is required to be submitted within the *earlier* of 30 days after receipt of our auditors' reports or nine months after the end of the audit period, unless specifically waived by a federal cognizant or oversight agency for audits. Data Collection Forms submitted untimely are one of the factors in assessing programs at a higher risk.

#### **Audit of the Financial Statements**

We will conduct our audits in accordance with GAAS, the standards applicable to financial audits contained in *Government Auditing Standards*, issued by the Comptroller General of the United States of America, the audit requirements of Title 2 U.S. Code of Federal Regulations (CFR) Part 200, *Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards* (Uniform Guidance). As part of an audit of financial statements in accordance with GAAS and in accordance with Government Auditing Standards, Uniform Guidance and/or any state or regulatory audit requirements we exercise professional judgment and maintain professional skepticism throughout the audit. We also:

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud
  or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is
  sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material
  misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve
  collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that
  are appropriate in the circumstances, but not for the purpose of expressing an opinion on the
  effectiveness of the entity's internal control. However, we will communicate to you in writing concerning
  any significant deficiencies or material weaknesses in internal control relevant to the audit of the financial
  statements that we have identified during the audit.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements, including the disclosures, and whether the financial statements represent the underlying transactions and events in a manner that achieves fair presentation.
- Conclude, based on the audit evidence obtained, whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Park District ability to continue as a going concern for a reasonable period of time.

Because of the inherent limitations of an audit, together with the inherent limitations of internal control, an unavoidable risk that some material misstatements or noncompliance may not be detected exists, even though the audit is properly planned and performed in accordance with GAAS and *Government Auditing Standards* of the Comptroller General of the United States of America.

Our responsibility as auditors is limited to the period covered by our audit and does not extend to any other periods.

We will issue a written report upon completion of our audit of the Park District's basic financial statements. Our report will be addressed to the governing body of the Park District. Circumstances may arise in which our report may differ from its expected form and content based on the results of our audit. Depending on the nature of these circumstances, it may be necessary for us to modify our opinions, add an emphasis-of-matter or othermatter paragraph(s) to our auditor's report, or if necessary, withdraw from the engagement. If our opinions on the basic financial statements are other than unmodified, we will discuss the reasons with you in advance. If, for any reason, we are unable to complete the audit or are unable to form or have not formed opinions, we may decline to express opinions or to issue a report as a result of this engagement.

In accordance with the requirements of *Government Auditing Standards*, we will also issue a written report describing the scope of our testing over internal control over financial reporting and over compliance with laws, regulations, and provisions of grants and contracts, including the results of that testing. However, providing an opinion on internal control and compliance over financial reporting will not be an objective of the audit and, therefore, no such opinion will be expressed.

### **Audit of Major Program Compliance**

Our audit of the Park District's major federal award program(s) compliance will be conducted in accordance with the requirements of the Single Audit Act, as amended; and the Uniform Guidance and will include tests of accounting records, a determination of major programs in accordance with the Uniform Guidance, and other procedures we consider necessary to enable us to express such an opinion on major federal award program compliance and to render the required reports. We cannot provide assurance that an unmodified opinion on compliance will be expressed. Circumstances may arise in which it is necessary for us to modify our opinion or withdraw from the engagement.

The Uniform Guidance requires that we also plan and perform the audit to obtain reasonable assurance about whether the material noncompliance with applicable laws and regulations, the provisions of contracts and grant agreements applicable to major federal award programs, and the applicable compliance requirements occurred, whether due to fraud or error, and express an opinion on the entity's compliance based on the audit. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS, *Government Auditing Standards*, and the Uniform Guidance will always detect material noncompliance when it exists. The risk of not detecting material noncompliance resulting from fraud is higher than for that resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Noncompliance with the compliance requirements is considered material if there is a substantial likelihood that, individually or in the aggregate, it would influence the judgment made by a reasonable user of the report on compliance about the entity's compliance with the requirements of the federal programs as a whole.

As part of a compliance audit in accordance with GAAS and in accordance with *Government Auditing Standards*, we exercise professional judgment and maintain professional skepticism throughout the audit. We also identify and assess the risks of material noncompliance, whether due to fraud or error, and design and perform audit procedures responsive to those risks.

Our procedures will consist of determining major federal programs and performing the applicable procedures described in the U.S. Office of Management and Budget OMB Compliance Supplement for the types of compliance requirements that could have a direct and material effect on each of the entity's major programs, and performing such other procedures as we considers necessary in the circumstances The purpose of those procedures will be to express an opinion on the entity's compliance with requirements applicable to each of its major programs in our report on compliance issued pursuant to the Uniform Guidance.

Also, as required by the Uniform Guidance, we will obtain an understanding of the entity's internal control over compliance relevant to the audit in order to design and perform tests of controls to evaluate the effectiveness of the design and operation of controls that we consider relevant to preventing or detecting material noncompliance with compliance requirements applicable to each of the entity's major federal award programs. Our tests will be less in scope than would be necessary to render an opinion on these controls and, accordingly, no opinion will be expressed in our report. However, we will communicate to you, regarding, among other matters, the planned scope and timing of the audit and any significant deficiencies and material weaknesses in internal control over compliance that we have identified during the audit.

We will issue a report on compliance that will include an opinion or disclaimer of opinion regarding the entity's major federal award programs, and a report on internal controls over compliance that will report any significant deficiencies and material weaknesses identified; however, such report will not express an opinion on internal control.

### **Management Responsibilities**

Our audit will be conducted on the basis that management and, when appropriate, those charged with governance, acknowledge and understand that they have responsibility:

- 1. For the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America;
- 2. For the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error;
- 3. For identifying, in its accounts, all federal awards received and expended during the period and the federal programs under which they were received;
- 4. For maintaining records that adequately identify the source and application of funds for federally funded activities;
- 5. For preparing the schedule of expenditures of federal awards (including notes and noncash assistance received) in accordance with the Uniform Guidance;
- 6. For designing, implementing, and maintaining effective internal control over federal awards that provides reasonable assurance that the entity is managing federal awards in compliance with federal statutes, regulations, and the terms and conditions of the federal awards;
- 7. For identifying and ensuring that the entity complies with federal laws, statutes, regulations, rules, provisions of contracts or grant agreements, and the terms and conditions of federal award programs and implementing systems designed to achieve compliance with applicable federal statutes, regulations, and the terms and conditions of federal award programs;
- 8. For disclosing accurately, currently, and completely, the financial results of each federal award in accordance with the requirements of the award;

- 11. For addressing the findings and recommendations of auditors, for establishing and maintaining a process to track the status of such findings and recommendations and taking corrective action on reported audit findings from prior periods and preparing a summary schedule of prior audit findings;
- 12. For following up and taking corrective action on current year audit findings and preparing a corrective action plan for such findings;
- 13. For submitting the reporting package and data collection form to the appropriate parties;
- 14. For making the auditor aware of any significant contractor relationships where the contractor is responsible for program compliance;
- 15. To provide us with:
  - a. Access to all information of which management is aware that is relevant to the preparation and fair presentation of the financial statements including disclosures, and relevant to federal award programs, such as records, documentation, and other matters;
  - b. Additional information that we may request from management for the purpose of the audit; and
  - c. Unrestricted access to persons within the entity and others from whom we determine it necessary to obtain audit evidence.
- 16. For adjusting the financial statements to correct material misstatements and confirming to us in the management representation letter that the effects of any uncorrected misstatements aggregated by us during the current engagement and pertaining to the current year period(s) under audit are immaterial, both individually and in the aggregate, to the financial statements as a whole;
- 17. For acceptance of nonattest services, including identifying the proper party to oversee nonattest work;
- 18. For maintaining adequate records, selecting and applying accounting principles, and safeguarding assets;

- 19. For informing us of any known or suspected fraud affecting the entity involving management, employees with significant role in internal control and others where fraud could have a material effect on compliance;
- 20. For the accuracy and completeness of all information provided;
- 21. For taking reasonable measures to safeguard protected personally identifiable and other sensitive information; and
- 22. For confirming your understanding of your responsibilities as defined in this letter to us in your management representation letter.

With regard to the schedule of expenditures of federal awards referred to above, you acknowledge and understand your responsibility (a) for the preparation of the schedule of expenditures of federal awards in accordance with the Uniform Guidance, (b) to provide us with the appropriate written representations regarding the schedule of expenditures of federal awards, (c) to include our report on the schedule of expenditures of federal awards in any document that contains the schedule of expenditures of federal awards and that indicates that we have reported on such schedule, and (d) to present the schedule of expenditures of federal awards with the audited financial statements, or if the schedule will not be presented with the audited financial statements, to make the audited financial statements readily available to the intended users of the schedule of expenditures of federal awards no later than the date of issuance by you of the schedule and our report thereon.

With regard to the supplementary information referred to above, you acknowledge and understand your responsibility (a) for the preparation of the supplementary information in accordance with the applicable criteria, (b) to provide us with the appropriate written representations regarding supplementary information, (c) to include our report on the supplementary information in any document that contains the supplementary information and that indicates that we have reported on such supplementary information, and (d) to present the supplementary information with the audited financial statements, or if the supplementary information will not be presented with the audited financial statements, to make the audited financial statements readily available to the intended users of the supplementary information no later than the date of issuance by you of the supplementary information and our report thereon.

As part of our audit process, we will request from management and, when appropriate, those charged with governance, written confirmation concerning representations made to us in connection with the audit.

We understand that your employees will prepare all confirmations we request and will locate any documents or invoices selected by us for testing.

If you intend to publish or otherwise reproduce the financial statements and make reference to our firm, you agree to provide us with printers' proofs or masters for our review and approval before printing. You also agree to provide us with a copy of the final reproduced material for our approval before it is distributed.

#### **Nonattest Services**

With respect to any nonattest services we perform, we agree to perform the following:

- Prepare or assist with preparing financial statements in conformity with U.S. generally accepted accounting principles based on information provided by you.
- Complete the auditee's portion of the Data Collection Form
- Prepare of assist with preparing the Schedule of Expenditures of Federal Awards
- Propose journal entries for the government-wide financial statements to be reviewed and approved by management.
- Prepare IRS Form 990 for the Fargo Park District Foundation and the Valley Senior Services Foundation

We will not assume management responsibilities on behalf of the Park District. The Park District's management understands and agrees that any advice or recommendation we may provide in connection with our audit engagement are solely to assist management in performing its responsibilities.

The Park District's management is responsible for (a) making all management decisions and performing all management functions; (b) assigning a competent individual to oversee the services; (c) evaluating the adequacy of the services performed; (d) evaluating and accepting responsibility for the results of the services performed; and (e) establishing and maintaining internal controls, including monitoring ongoing activities.

Our responsibilities and limitations of the nonattest services are as follows:

- We will perform the services in accordance with applicable professional standards.
- The nonattest services are limited to the services previously outlined above. Our firm, in its sole professional judgment, reserves the right to refuse to do any procedure or take any action that could be construed as making management decisions or assuming management responsibilities.

#### **Fees and Timing**

Brian Stavenger is the engagement partner for the audit services specified in this letter. The engagement partner's responsibilities include supervising services performed as part of this engagement and signing or authorizing another qualified firm representative to sign the audit report.

#### **EMPLOYMENT AGREEMENT**

This EMPLOYMENT AGREEMENT (this "Agreement") is effective as of December 12, 2023 ("Effective Date") and is between THE PARK DISTRICT OF THE CITY OF FARGO, a park district organized under the laws of the State of North Dakota ("Park District") and SUSAN FAUS ("Employee").

**WHEREAS**, the Park District offered Employee the position of Executive Director of the Park District's operations; and

**WHEREAS**, Employee has accepted such offer of employment and desires to commit herself to employment with the Park District on the terms herein provided.

**NOW, THEREFORE**, in consideration of the foregoing and of the respective covenants and agreements set forth below, the parties hereto agree as follows:

### 1. **Definitions**:

- 1.1. "Annual Salary" means the Employee's annual base salary described in Section 2.4.1.
- 1.2. "Cause" means:
  - 1.2.1. A material breach of this Agreement by Employee which is not cured by Employee within thirty (30) days of written notice from the Park District specifying the acts or omissions giving rise to such material breach.
  - 1.2.2. Employee's intentional nonperformance of her duties, or refusal to abide by or comply with the reasonable directives of her superiors, or the Park District's policies and procedures which is not cured by Employee within thirty (30) days of written notice from the Park District specifying the nonperformance or noncompliance in question.
  - 1.2.3. The Employee willfully engaging in misconduct, which is materially injurious to Park District, monetarily or otherwise.
  - 1.2.4. The commission of a criminal act by Employee against the Park District, including but not limited to fraud, embezzlement, or theft; and
  - 1.2.5. The conviction or plead of no contest or nolo contendere for any felony, or for a misdemeanor that is substantially related to the Employee's job with the Park District.
- 1.3. "Disability" means Employee's disability within the meaning of any long-term disability plan maintained by Park District and covering Employee then in effect, or Employee's continuous inability during a period of ninety (90) calendar days in any twelve (12) month period to perform Employee's material duties hereunder as a result of physical or mental illness, loss of legal capacity, or any other cause beyond Employee's control. In the event of a dispute between the parties as to whether or not the Employee is disabled, whether or not the Employee is disabled will be determined by the mutual agreement of a physician selected by the Park District or its insurers (the "Park District Physician") and a physician

selected by Employee ("Employee's Physician"). In the event that the Park District Physician and Employee's Physician cannot agree on whether Employee is disabled, such determination will be made by a third physician who is jointly selected by the Park District Physician and Employee's Physician.

- 1.4. "Good Reason" means the occurrence, without the consent of Employee, of any of the following: (i) the material diminution of Employee's position, authority, duties or responsibilities as contemplated in Section 2.3; (ii) any material reduction in Employee's salary; (iii) any material reduction in the aggregate benefits available to Employee; or (iv) any material breach of this Agreement by the Park District.
- 1.5. "Without Cause" means termination by the Park District of Employee's employment at the Board of Commissioner's sole discretion for any reason, other than by reason of Employee's death or Disability, and other than a termination based upon Cause.

### 2. Terms of Employment and Duties:

- 2.1. <u>Term.</u> The term of this Agreement will be for the period commencing on the Effective Date to December 31, 2025 (the "Initial Term"), subject to early termination pursuant to the provisions of Section 3.
- 2.2. <u>Renewal</u>. This Agreement and all terms contained herein shall automatically renew on a year-to-year basis (the "Renewal Term") after the expiration of the Initial Term on December 31, 2025, or any Renewal Term which shall expire on December 31 of each Renewal Term, without further action of the Park District or Employee, provided the same has not been terminated in accordance with Section 3, below.
- 2.3. <u>Position, Duties and Services</u>. Park District hereby employs Employee and Employee here accepts employment from Park District, subject to the terms and conditions of this Agreement. Employee will serve full-time as the Executive Director of the Park District and will have such authority, title and duties as will be determined from time to time by the Board of Commissioners, and as are customarily associated with such position in accordance with industry standards. Employee shall report to the Board of Commissioners and will be responsible for the overall operations of the Park District. Employee will perform such duties diligently and faithfully and in a manner that promotes the interests of the Park District. See attached Executive Direction job description for reference.

### 2.4. Compensation.

2.4.1. Annual Salary. Employee will receive an initial annual salary of \$185,000.00 (the "Annual Salary"), payable in periodic installments in accordance with the Park District's normal payroll practices and procedures. The Annual Salary shall be prorated for the month containing the Effective Date. In the event of early termination pursuant to Section 1, Employee's Annual Salary shall be paid according to the applicable provisions of Section 3. The Annual Salary may be adjusted from time to time by the Board of Commissioners. Absent an adjustment from the Board of Commissioners, Employee's Annual Salary shall increase in the same amount as all other Park District employees on an annual basis.

- 2.4.2. Park District Benefit Plans. During the Term of this Agreement, Employee will receive the benefits set forth on Schedule A attached hereto (in accordance with the terms of the Park District's applicable benefits plans) and shall otherwise be entitled to participate in all incentive, savings, profit sharing and retirement plans, medical benefit plans, leave policies, practices, policies, and programs applicable generally, from time to time, to other similarly situated employees of the Park District. For purposes of specific benefit's offered, Employee shall be fall into the following classifications:
  - 2.4.2.1. Vacation: 13-18 years of experience
  - 2.4.2.2. Sick Time: 11+ years of experience
  - 2.4.2.3. Volunteer Retirement: 4 years of experience
- 2.4.3. Reimbursement of Expenses. The Park District shall pay or reimburse Employee for reasonable travel and entertainment and other expense incurred by Employee in connection with the performance of Employee's duties and in accordance with the Park District's regular reimbursement procedures and practices. The Park District shall pay for professional fees and memberships associated with the Employee's position, as approved by the Board of Commissioners. The Park District shall pay expenses for the Employee's attendance at appropriate seminars, conferences and boards, subject to approval by the Board of Commissioners.
- 2.5. <u>Performance Review</u>. The Board of Commissioners shall conduct an annual formal review of Employee's performance and salary. The annual formal review shall occur annually on or about the end of the calendar year.

### 3. <u>Termination</u>:

- 3.1. <u>Death</u>. Upon the death of Employee during the Initial Term or a Renewal Term, the Agreement will terminate and Employee's estate will be entitled to payment of her Annual Salary through the date of death, plus any benefits accrued up to the date of her death, payable pursuant to the terms of the benefit plans specified in this Agreement or Schedule A in which Employee is a participant.
- 3.2. <u>Disability</u>. In the event of Employee's Disability during the Initial Term or a Renewal Term, the Park District may terminate Employee's employment, in which case this Agreement will terminate and Employee will be entitled to payment of the following benefits: (i) her Annual Salary through the effective date of such termination, (ii) long-term disability benefits pursuant to the terms of any long-term disability policy provided to similarly-situated employees of the Park District in which Employee has elected to participate and (iii) payment of any benefits payable pursuant to the terms of the benefit plans specified in this Agreement or Schedule A in which Employee is a participant.
- 3.3. <u>Termination for Cause or Voluntary Resignation by Employee Without Good Cause</u>. If Employee's employment is terminated during the Initial Term or any Renewal Term for Cause or if Employee voluntarily resigns from the employment without Good Reason

prior to the expiration of the Initial Term or any Renewal Term, or any other reason after providing the Park District with not less than ninety (90) days' prior written notice of such resignation, the Park District will pay Employee through the effective date of termination: (i) her Annual Salary in effect at the time notice of termination is given, and (ii) payment of any benefits specified in this Agreement or Schedule A, payable to Employee pursuant to the terms of such benefit plans in which Employee is a participant, subject to any forfeiture of such benefits as may be permissible under the law and such plans due to the nature of the cause of termination.

- 3.4. Employee's Termination for Good Reason. During the Initial Term or a Renewal Term, Employee shall have the right to terminate this Agreement and Employee's employment hereunder at any time for Good Reason upon written notice given to the Park District. Formal notice is required to be given to the current President of the Board of Commissioners with a copy to Human Resources of the Fargo Park District. The Board of Commissioners shall have 15 days from receipt of the written notice by Employee to contest Employee's Good Reason for terminating employment. If it is determined that Employee's employment is terminated by Employee for Good Reason, the Park District will pay Employee the lesser of (i) her unpaid, applicable Annual Salary for six (6) months from the date of termination, or (ii) her unpaid, applicable Annual Salary from the date of termination to the end of the Term. If the Park District determines that Employee's termination is not for Good Reason, then the Park District will pay Employee through the date of termination.
- 3.5. Park District's Termination Without Cause or Non-Renewal of Agreement Without Cause. If Employee's employment is terminated by the Park District Without Cause or if this Agreement is not renewed by the Board of Commissioners for reasons Without Cause, the Park District will pay Employee her unpaid, applicable Annual Salary for 12 months from the date of termination or non-renewal. During such period, the Park District will pay any benefits payable pursuant to the terms of the benefit plans specified in this Agreement or Schedule A in which Employee is a participant.
  - 3.5.1. The Park District's obligation to pay Employee applicable Annual Salary for 12 months from the date of termination or non-renewal under this Section 3.5 shall terminate on December 31, 2033. If Employee's employment is terminated by the Park District Without Cause or if this Agreement is not renewed by the Board of Commissioners for reasons Without Cause after December 31, 2033, then the Park District shall not owe any salary to Employee beyond the termination date.

### 4. Open Records.

4.1. Employee understands and acknowledges that the Park District is a public entity, as defined by North Dakota law, and is generally subject to state open records and open meetings laws. Employee hereby agrees that, in the event Employee is asked to assist the Park District in complying with such open records and open meetings laws, Employee agrees that she shall fully cooperate with the Park District, its agents and attorneys to ensure the Park District's compliance.

### 5. Miscellaneous.

- 5.1. Governing Law/Venue. This Agreement is governed by and will be construed in accordance with the laws of the State of North Dakota. Each party agrees that it will not bring any action relating to this Agreement or any acts or transactions contemplated herein in any court other than a federal or state court sitting in Cass County, North Dakota. Each party further agrees that it will submit to the jurisdiction of such court and will not seek to change the venue of such action.
- 5.2. <u>Amendment and Waiver</u>. The provisions of this Agreement may be amended, modified or waived only with the prior written consent of the Board of Commissioners and Employee, and no course of conduct or failure or delay in enforcing the provisions of this Agreement will be constructed as a waiver of such provisions or affect the validity, binding effect or enforceability of this Agreement or any provision hereof.
- 5.3. <u>Assignment</u>. This Agreement shall be non-assignable by either party hereto without the prior written consent of both parties. Any attempted assignment hereof without consent shall be in all events null and void.
- 5.4. Severability. Any provision in this Agreement which is prohibited or unenforceable in any jurisdiction by reason of applicable law will, as to such jurisdiction, be ineffective only to the extent of such prohibition or unenforceability without invalidating or affecting the remaining provision hereof, and any such prohibition or unenforceability in any jurisdiction will not invalidate or render unenforceable such provision in any other jurisdiction.
- 5.5. Entire Agreement. This Agreement embodies the complete agreement and understanding among the parties hereto with respect to Employee's employment with the Park District and supersedes and preempts any prior understandings, agreements or representations by or among the parties, written or oral, which may have related to such employment in any way.
- 5.6. Withholding of Taxes and Other Employee Deductions. The Park District may withhold from any benefits and payments made pursuant to this Agreement all federal, state, city and other taxes as may be required pursuant to any law or governmental regulation or ruling and all other normal employee deductions made with respect to the Park District's employees generally.
- 5.7. <u>Counterparts</u>. This Agreement may be executed in one or more counterparts (including means of facsimile), each of which shall be deemed an original but all of which together will constitute one and the same instrument.
- 5.8. <u>Notices</u>. All notices shall be given by personal delivery, by certified or registered first class mail, postage prepaid with return receipt requested, or by express delivery services such as Federal Express or Express Mail. Each such notice shall be effective if (a) delivered

personally by hand, when delivered at the address specified in this Article V (8), or (b) given by certified or registered first class mail, on the date appearing on the return receipt therefor or (c) given by express delivery services when delivered at the address specified in this Article V (8).

### Schedule A Benefits

As of the Effective Date, the Park District provides the following specific benefits:

**Health Insurance:** The Park District shall provide health insurance to Employee and his/her spouse and eligible dependents in accordance with Park District policies. See Summary Plan Description of the Park District's Health Benefits. The employer pays 75% of the monthly premium.

**Dental Insurance:** The Park District shall provide dental insurance to the Employee and his/her spouse and eligible dependents in accordance with the Park District policies. See Summary Plan Description of the Park District's Dental Benefits. The employer pays 100% of the single coverage.

**Long Term Disability Insurance:** The Park District shall provide disability insurance to Employee and pay 100% of the premium for such disability insurance in accordance with the Park District's plans and policies for employees similarly situated to Employee.

**Life Insurance:** The Park District shall provide life insurance to Employee and pay 100% of the premium for such life insurance in accordance with Company plans and policies for employees similarly situated to Employee. Policy pays \$50,000 in coverage. Additional coverage available at Employee expense.

- Dependent Care
- Optional Products Cancer, Hospital Indemnity, Accident, Disability, Vision

**Pension Fund NDPERS:** Employee is required to participate in the pension plan through NDPERS. The Employee contributes 7% of their monthly salary with the Employer contributing 8.26%.

**457 Retirement Plan:** Employee shall be allowed to participate in the Company's 457 plan upon eligibility.

**Other Expense Reimbursements:** The Park District shall reimburse Employee for travel, lodging, meal and other expenses pursuant to the terms and conditions of the Company's expense reimbursement policies applicable to similar situated employees of the Park District.

**EAP:** Employee Assistance Program is available to all employees through The Village Family Services.

Vacation: Benefit Eligibility, based on years of service.

• 3 years: 8 hours per month

• 4-7 years: 10 hours per month

to pursue the sale of the Depot

At the facilities committee on January 31, 2024, administration presented information requested as it pertains to seeking authority to go out for request for proposals for the sale of the Depot, located at 701 Main Avenue. Below is a summary of the items raised that needed additional information. Additional questions were raised at the meeting regarding the infusion of public funds to the building and the potential for special consideration that may be necessary as a result. Administration will continue to research any possible restrictions to a sale through the North Dakota State Historical Society.

- 1.) **Historical Registry:** The Northern Pacific Railway Depot, 701 Main Ave, Fargo, built in 1898 was listed on the National Register of Historic Places in 1975.
- 2.) **BNSF Easement:** The Fargo Park District (Grantee) agreed to an easement on 11/9/04 and was signed by BNSF (Grantor) on 2/14/05. The district paid \$22,100.00 for the easement. It spells out particulars for each party as it pertains to maintenance, adjustments to the building, keeping area free of obstruction, etc. The easement also references the "Grantee on behalf of themselves, his heirs, successors and assigns . . . ", which indicates, if we sell the property, our "successor" will have the same obligations under the easement.
- 3.) **Depot Plaza Dedication Program:** The Depot Plaza program was designed for the Depot Plaza, and the Park District's involvement is primarily due to our ownership at the time of establishment and our overall public interest. There is a "Depot Area Beautification and Maintenance Fund" at the FM Area Foundation with approximately \$170,000 in the fund. This program extends beyond the sale of the bricks, it also included site furnishings such as, the fountain, park benches, trees, bollards, the Depot Plaza Clock, hanging lights, an many other donated items. The fund could be assigned to the new ownership and ongoing maintenance of the program.
- 4.) **Improvement Costs:** Staff is continuing to review facility assessment data to determine potential improvement costs to the property.
