OF THE FARGO PARK DISTRICT OF AUGUST 11, 2026**

The regular monthly meeting of the Board of Commissioners of the Park District of the City of Fargo was held on Tuesday, August 11, 2026, at 5:30 p.m. at the Fargo Park District office at 6100 38th Street South, Fargo, North Dakota and via Restream. Present at the meeting were Commissioners Joe Deutsch, Zoé Absey, Emily Secor May, Jerry Rostad and Vicki Dawson. Also present were: Susan Faus, and attorney Jeff Gunkelman.

Approval of Agenda

Commissioner Vicki Dawson moved and Commissioner Joe Deutsch seconded a motion to approve the agenda as presented. Upon call of the roll, the motion passed unanimously.

Approval of Consent Agenda

Commissioner Joe Deutsch moved and Commissioner Vicki Dawson seconded a motion to approve the following actions on the consent agenda:

Approval of Covey Ranch Developers Agreement

It was noted that the plan is for a 6.31 acre park with a warming house and multiple-purpose building, public art; a paved parking lot, a plaza and shelter, and a combination of paved and walking trails. It was noted that the total cost of the planned park is estimated at \$2,980,000.00 but that approximately \$640,000.00 of that cost will be contributed by developers for payment in lieu agreements. It was noted that the Developers are still working with the city to get the development platted and that the Park District is trying to work more closely with developers in the pre-platting process.

Commissioner Vicki Dawson moved and Commissioner Zoé Absey seconded a motion to approve the Covey Ranch Developers Agreement as presented to the Board. Upon call of the roll, the motion passed unanimously.

Fargo Parks Sports Center Update

Kali Mork updated the Board on usage, financials, and future plans related to the Fargo Parks Sports Center. No action was taken on this matter.

2027 Budget Review

Broc Lietz updated the Board on the budget process in advance of the formal budget procedures to be coming in the following months. No action was taken on this matter.

RE: Consent Agenda Item (d) – Approval of Bid for Snow Removal Services at the Fargo Parks Sports Center

The Fargo Parks Sports Center team received four proposals for snow removal at the facility for the next three consecutive snow seasons: 2026-27, 2027-28, and 2028-29.

Pro Land Snow submitted a proposal of \$17,850 per month for all three seasons. JT Lawn and Snow - \$11,500, \$12,000, \$12,500 for 2026-2027, 2027-2028 and 2028-2029 respectively. Glacier Snow Management - \$9,500, \$9,500, \$10,000 per month for each respective year. Asplin Siteworks Inc - \$14,750, \$18,750, \$22,500 per month for each respective year. A bid sheet summary is attached to this memo.

The contract runs October 15th through April 15th. Snow removal services trigger at 1" of snowfall. Each proposal has a flat rate per month regardless of snowfall totals. The flat rate covers all parking lots and access roads leading to these lots. The Sports Center team will take care of all the sidewalks. Hauling of snow out of lots and salting/sanding services are an additional fee.

Having reviewed the submitted proposals, staff recommend moving forward with a 3-year agreement with Glacier Snow Management. The proposal met all the specifications and is the lowest proposal. It also fits within the amount allocated for snow removal within the Sports Center's operational budget.

It was recommended at the August 19 Planning Committee meeting to move this item to the full board for approval

At the Planning Committee meeting on September 19, 2026, the Amendment to the Southwest Regional Pond MOU was presented. It was recommended by the committee to strengthen the language to make sure the City and the Park District work together on any future replacement costs associated with the trails and box culverts. Included with this memo is a redlined version of the MOU to represent this change in language.

The Park District and the City of Fargo have an existing Memorandum of Understanding (MOU) for the Southwest Regional Pond area that spans from 52nd Avenue South and 64th Avenue South in between 45th Street South and Veterans Boulevard that was executed in November 2021 to spell out each parties' responsibilities for future development of the area, maintenance, and other various items. The existing agreement is attached for your reference.

The City of Fargo approached the Park District earlier this year with the idea of amending the current MOU to include the far South pond area that is located South of 64th Avenue South as shown in the attached exhibit to spell out future development responsibilities, maintenance, and replacement of amenities in the future when needed.

**AMENDMENT TO
MEMORANDUM OF UNDERSTANDING REGARDING CONSTRUCTION,
MAINTENANCE AND PURCHASE OPTION**

This Amendment to Memorandum of Understanding (“Amendment”) is entered into between the City of Fargo, whose address is 225 4th Street North, Fargo, North Dakota 58102 (“Fargo”), and the Park District of the City of Fargo, whose address is 6100 38th Street South, Fargo, North Dakota 58104 (the “Park District”).

WHEREAS, North Dakota Century Code § 40-05.1-6 and Article 3 of Fargo’s Home Rule Charter authorizes Fargo to enter into contracts; and

WHEREAS, North Dakota Century Code § 40-49-04 authorizes the Park District to enter into contracts; and

WHEREAS, in or about November 2021, Fargo and the Park District entered into a Memorandum of Understanding Regarding Construction, Maintenance and Purchase Option (“MOU” or “Agreement”) related to a stormwater retention pond located south of 52nd Avenue South along Drain No. 27, which is commonly known as the Southwest Metro Regional Storm Water Pond; and

WHEREAS, the MOU contemplated the construction of the Southwest Metro Regional Storm Water Pond in phases, and Fargo is currently in the process of constructing additional pond infrastructure; and

WHEREAS, the parties now desire to add additional terms to and otherwise modify the MOU in accordance with the terms of this Amendment; and

WHEREAS, the parties agree that the existing MOU will remain in full force and effect as modified or amended by this Amendment.

NOW THEREFORE, in consideration of the mutual terms, covenants, conditions, and agreements contained herein, it is hereby agreed by and between the parties as follows:

1. Definition of “Pond Property”. The definition of the term “Pond Property” as used in the MOU and this Amendment is hereby amended to include the additional phase of the storm water retention pond to be located south of 64th Avenue South as part of the overall City storm sewer system. As used herein, the “North Pond” shall refer to the northernmost portion of the Southwest Metro Regional Storm Water Pond, lying between 52nd Avenue South and 64th Avenue South. As used herein, the “South Pond” shall refer to the southernmost portion of the Southwest Metro Regional Storm Water Pond, lying south of 64th Avenue South. The definition of the term “Pond Property” shall now include both the “North Pond” and the “South Pond” as depicted and represented in Exhibit A, which is attached hereto and made part of this Amendment.
2. Use of the Term “Pond Parcel”. The term “Pond Parcel” as used throughout the MOU shall have the same meaning as “Pond Property” defined in Paragraph 1 above.

3. The parties hereby agree that Paragraph 3 of the MOU be amended as follows:

3. Storm Water Retention Pond Construction and Maintenance.

a. Fargo has entered a single contract for construction of the North Pond and South Pond. It is anticipated that completion of construction will occur by September 2026. Fargo shall be solely responsible for the construction of the North Pond and South Pond and all necessary appurtenances thereto, including installation of storm water pipe and structures. Fargo is further responsible for planting crop cover vegetation within the newly disturbed areas of the North Pond and South Pond. Park District, in conjunction with the Audubon Great Plains, shall plant a native grass mixture within the Pond Property at the appropriate time, and then be responsible for the establishment, weed control, and general maintenance of the native grasses and vegetation thereafter.

b. Fargo shall be responsible for future pond maintenance, for both the North Pond and South Pond, including but not limited to sediment removal, inspection, bank sloughing repair, and/or replacement and other maintenance deemed necessary by Fargo, in its sole discretion. Fargo shall not be responsible for repairing or correcting erosion or bank sloughing which Fargo deems insignificant or unnecessary to repair, nor repairing or maintaining any Park District improvements made within the Pond Property.

4. The parties hereby agree that the following provisions are added to Paragraph 5 of the MOU:

d) The entire shared-use path network around the South Pond will not be fully constructed with the initial pond and infrastructure project adjacent to the South Pond. The shared-use path network will instead be a multi-year construction process completed in phases as development and other infrastructure build out occurs adjacent and along the South Pond. The parties hereby agree to work collaboratively to determine the extent and location of the shared-use path network as development and other infrastructure build out occurs adjacent to and along the South Pond.

e) Construction of the shared-use path network around the South Pond will be included and funded as part of the infrastructure build out projects adjacent to and along the South Pond.

f) Park District shall be responsible for the shared-use path pavement maintenance, repairs, and snow and debris removal. Park District's responsibilities stated herein include those portions between the North Pond and South Pond.

g) Park District and Fargo hereby acknowledge and agree that reconstruction of the shared-use paths may become necessary in the future. The parties agree to cooperate, ~~and~~ coordinate, and work together in good faith regarding ~~as to~~ any future reconstruction of the shared-use paths. If the parties determine and agree that reconstruction is necessary, the parties will then coordinate to review the scope, timing, and responsibilities associated with such reconstruction. The terms, conditions, rights, and responsibilities as to any future

reconstruction of the shared-use paths shall be the subject of a separate agreement between the parties.

- h) Park District and Fargo hereby acknowledge and agree that structural repairs and replacement of the pedestrian box culverts underlying 64th Avenue South and 45th Street South may become necessary in the future. The parties agree to cooperate, ~~and coordinate,~~ and work together in good faith regarding-as to any future repairs and replacement of the pedestrian box culverts. If Fargo determines that repairs or replacement of the pedestrian box culverts are necessary, the parties will then coordinate to review the scope, timing, and responsibilities associated with such repairs or replacement. The terms, conditions, rights, and responsibilities as to any future repairs and replacement of the pedestrian box culverts shall be the subject of a separate agreement between the parties.

5. The parties hereby agree that Paragraph 13 of the MOU be amended as follows:

13. Notice. Any notice of election required or permitted to be given or served by any party to this MOU upon any other will be deemed given or served in accordance with the provisions of this MOU if said notice or election is (a) delivered personally, or (b) mailed by United States certified mail, return receipt requested, postage prepaid, and in any case properly address as follows:

Each such mailed notice or communication will be deemed to have been given on the date the same is deposited in the United States mail. Each such delivered notice or communication will be deemed to have been given upon the delivery. Any party may change its address for service of notice in the manner specified in this MOU.

6. Except as amended or modified herein, the Memorandum of Understanding Regarding Construction, Maintenance and Purchase Option entered between the parties in or about November 2021 shall remain in full force and effect and binding upon the parties.

7. This Amendment shall become effective upon the date the last executed by the parties to the Amendment.

This Amendment to Memorandum of Understanding (“Amendment”) is entered into between the City of Fargo, whose address is 225 4th Street North, Fargo, North Dakota 58102 (“Fargo”), and the Park District of the City of Fargo, whose address is 6100 38th Street South, Fargo, North Dakota 58104 (the “Park District”).

WHEREAS, North Dakota Century Code § 40-05.1-6 and Article 3 of Fargo’s Home Rule Charter authorizes Fargo to enter into contracts; and

WHEREAS, North Dakota Century Code § 40-49-04 authorizes the Park District to enter into contracts; and

WHEREAS, in or about November 2021, Fargo and the Park District entered into a Memorandum of Understanding Regarding Construction, Maintenance and Purchase Option (“MOU” or “Agreement”) related to a stormwater retention pond located south of 52nd Avenue South along Drain No. 27, which is commonly known as the Southwest Metro Regional Storm Water Pond; and

WHEREAS, the MOU contemplated the construction of the Southwest Metro Regional Storm Water Pond in phases, and Fargo is currently in the process of constructing additional pond infrastructure; and

WHEREAS, the parties now desire to add additional terms to and otherwise modify the MOU in accordance with the terms of this Amendment; and

WHEREAS, the parties agree that the existing MOU will remain in full force and effect as modified or amended by this Amendment.

NOW THEREFORE, in consideration of the mutual terms, covenants, conditions, and agreements contained herein, it is hereby agreed by and between the parties as follows:

1. Definition of “Pond Property”. The definition of the term “Pond Property” as used in the MOU and this Amendment is hereby amended to include the additional phase of the storm water retention pond to be located south of 64th Avenue South as part of the overall City storm sewer system. As used herein, the “North Pond” shall refer to the northernmost portion of the Southwest Metro Regional Storm Water Pond, lying between 52nd Avenue South and 64th Avenue South. As used herein, the “South Pond” shall refer to the southernmost portion of the Southwest Metro Regional Storm Water Pond, lying south of 64th Avenue South. The definition of the term “Pond Property” shall now include both the “North Pond” and the “South Pond” as depicted and represented in Exhibit A, which is attached hereto and made part of this Amendment.
2. Use of the Term “Pond Parcel”. The term “Pond Parcel” as used throughout the MOU shall have the same meaning as “Pond Property” defined in Paragraph 1 above.

3. The parties hereby agree that Paragraph 3 of the MOU be amended as follows:

3. Storm Water Retention Pond Construction and Maintenance.

a. Fargo has entered a single contract for construction of the North Pond and South Pond. It is anticipated that completion of construction will occur by September 2026. Fargo shall be solely responsible for the construction of the North Pond and South Pond and all necessary appurtenances thereto, including installation of storm water pipe and structures. Fargo is further responsible for planting crop cover vegetation within the newly disturbed areas of the North Pond and South Pond. Park District, in conjunction with the Audubon Great Plains, shall plant a native grass mixture within the Pond Property at the appropriate time, and then be responsible for the establishment, weed control, and general maintenance of the native grasses and vegetation thereafter.

b. Fargo shall be responsible for future pond maintenance, for both the North Pond and South Pond, including but not limited to sediment removal, inspection, bank sloughing repair, and/or replacement and other maintenance deemed necessary by Fargo, in its sole discretion. Fargo shall not be responsible for repairing or correcting erosion or bank sloughing which Fargo deems insignificant or unnecessary to repair, nor repairing or maintaining any Park District improvements made within the Pond Property.

4. The parties hereby agree that the following provisions are added to Paragraph 5 of the MOU:

d) The entire shared-use path network around the South Pond will not be fully constructed with the initial pond and infrastructure project adjacent to the South Pond. The shared-use path network will instead be a multi-year construction process completed in phases as development and other infrastructure build out occurs adjacent and along the South Pond. The parties hereby agree to work collaboratively to determine the extent and location of the shared-use path network as development and other infrastructure build out occurs adjacent to and along the South Pond.

e) Construction of the shared-use path network around the South Pond will be included and funded as part of the infrastructure build out projects adjacent to and along the South Pond.

f) Park District shall be responsible for the shared-use path pavement maintenance, repairs, and snow and debris removal. Park District's responsibilities stated herein include those portions between the North Pond and South Pond.

g) Park District and Fargo hereby acknowledge and agree that reconstruction of the shared-use paths may become necessary in the future. The parties agree to cooperate, coordinate, and work together in good faith regarding any future reconstruction of the shared-use paths. If the parties determine and agree that reconstruction is necessary, the parties will then coordinate to review the scope, timing, and responsibilities associated with such reconstruction. The terms, conditions, rights, and responsibilities as to any future

reconstruction of the shared-use paths shall be the subject of a separate agreement between the parties.

- h) Park District and Fargo hereby acknowledge and agree that structural repairs and replacement of the pedestrian box culverts underlying 64th Avenue South and 45th Street South may become necessary in the future. The parties agree to cooperate, coordinate, and work together in good faith regarding any future repairs and replacement of the pedestrian box culverts. If Fargo determines that repairs or replacement of the pedestrian box culverts are necessary, the parties will then coordinate to review the scope, timing, and responsibilities associated with such repairs or replacement. The terms, conditions, rights, and responsibilities as to any future repairs and replacement of the pedestrian box culverts shall be the subject of a separate agreement between the parties.

5. The parties hereby agree that Paragraph 13 of the MOU be amended as follows:

13. Notice. Any notice of election required or permitted to be given or served by any party to this MOU upon any other will be deemed given or served in accordance with the provisions of this MOU if said notice or election is (a) delivered personally, or (b) mailed by United States certified mail, return receipt requested, postage prepaid, and in any case properly address as follows:

6. Except as amended or modified herein, the Memorandum of Understanding Regarding Construction, Maintenance and Purchase Option entered between the parties in or about November 2021 shall remain in full force and effect and binding upon the parties.

7. This Amendment shall become effective upon the date the last executed by the parties to the Amendment.

The Committee reviewed the accompanying correspondence from Division Engineer, Nathan Boerboom, regarding the approval of a Memorandum of Understanding between the City and the Fargo Park District, which specifies maintenance responsibilities for the Southwest Metro Regional Storm Water Pond.

This is standard for retention ponds that the City owns and teams with the Park District to program and assist with maintenance. Engineering, Public Works, and Planning have been collaborating on the development of the Southwest Metro Regional Storm Water Pond. During this collaboration, staff also worked with the Fargo Park District so that the final design of the pond could serve the community as both storm water infrastructure and a recreation amenity. Due to uncertainty of when the pond will be complete, staff has drafted an MOU to provide the Park District some discretion on its use of the pond property as long as it does not impact the functionality of the pond.

There will be an 80-acre remnant parcel that the City intends to sell at a future date. The MOU includes a provision agreeing to dedicate up to 8% (approximately 6.5 acres) of the remnant 80-acre parcel the City owns to the Park District. By completing this 8% dedication ahead of selling the parcel, the Park District agrees that the future owner of the remnant parcel will not need to dedicate any additional land to the Park District at the time of platting, which is a typical requirement for new plats. The MOU also has an option/right of first refusal for the Park District to buy additional portions of the remnant parcel at appraised value. As discussions continue on recreational uses, this allows the flexibility to the Park for the purchase of the land necessary to build support structure for programming.

Additional responsibilities detailed in the MOU are as follows:

- City of Fargo
 - Retain ownership of the property
 - Complete construction of the pond
 - Pond maintenance
 - Storm sewer maintenance
- Fargo Park District
 - Responsible for construction, repair, and maintenance of all amenities
 - Grass mowing and weed control
 - Tree planting, maintenance, and replacement

Staff is seeking approval of the Memorandum of Understanding between the City and the Fargo Park District for maintenance responsibilities of the Southwest Metro Regional Storm Water Pond property.

On a motion by Tim Mahoney, seconded by Bruce Grubb, the Committee voted to recommend approval of the Memorandum of Understanding with the Fargo Park District specifying maintenance responsibilities for the Southwest Metro Regional Storm Water Pond property.

**MEMORANDUM OF UNDERSTANDING REGARDING CONSTRUCTION,
MAINTENANCE AND PURCHASE OPTION**

This Memorandum of Understanding (“MOU” or “Agreement”) is entered into between the City of Fargo, whose address is 225 4th Street North, Fargo, North Dakota 58102 (“Fargo”), and the Park District of the City of Fargo, whose address is 701 Main Avenue, Fargo, North Dakota 58103 (the “Park District”).

WHEREAS, North Dakota Century Code § 40-05.1-6 and Article 3 of Fargo’s Home Rule Charter authorizes Fargo to enter into contracts; and

WHEREAS, North Dakota Century Code § 40-49-04 authorizes the Park District to enter into contracts; and

WHEREAS, Fargo is in the process of constructing the first phase of a storm water retention pond as part of the overall City storm sewer system, as shown in Exhibit “A” attached hereto (hereinafter the “Pond Property”); and

WHEREAS, Fargo and Park District recognize that the project will be constructed in several phases, and that the completion dates of the various phases are unknown. Nevertheless, Fargo and Park District intend for this MOU to be effective as to all phases of construction of the Pond Project; and

WHEREAS, Fargo and Park District desire to have the Pond Property be a dual- purpose project to serve the community as both storm water infrastructure and a recreational amenity; and

WHEREAS, Park District desires to construct certain amenities on the Pond Property, at its cost; and

WHEREAS, Park District has expressed interest in buying a portion of the City property adjacent to the Pond Parcel (“Remnant Parcel”) in the future if City determines the Remnant Parcel is not needed for the primary purpose of storm water retention, and City agrees Park District should have primacy to the land in the event of its sale; and

WHEREAS, Fargo and Park District recognize that joint operation and programming may improve the ability to secure additional funding and other cooperative relationships to benefit the community; and

WHEREAS, Fargo shall have the responsibility of construction, maintenance, inspection and repair of the storm water retention pond; and

WHEREAS, the Park District shall have the responsibility of construction, maintenance, inspection, and repair of the park amenities, subject to the terms of this Agreement.

NOW THEREFORE, in consideration of the mutual terms, covenants, conditions, and agreements contained herein, it is hereby agreed by and between the parties as follows:

1. Ownership. Fargo owns the parcel on which the storm water retention pond and other amenities have been, or will be, constructed in phases, and Fargo and Park District agree and understand that the City shall retain ownership of the Pond Parcel at all times, without regard to maintenance responsibilities. The parties understand and agree that the primary use of the property is for storm water retention and detention, and such purpose shall not be impaired or impeded by any provisions herein.

2. Access. Fargo hereby grants Park District access for ingress and egress, and for purposes of maintenance and construction, as necessary to carry out the terms of this Agreement. Park District agrees to ensure unimpeded access to the installed amenities for whatever purpose deemed necessary by City, including patrol, emergency access, and truck access, as necessary. In the event Park District is permitted to install gates or other access controls to the Pond Parcel, Park District shall ensure access to City is not hindered or impaired in any way, and shall provide such keys, codes or other means to access the Pond Parcel, without delay.

3. Storm Water Retention Pond Construction and Maintenance.

a. Fargo shall be solely responsible for the construction of the storm water retention pond and all necessary appurtenances thereto, including installation of storm water pipe and structures, and, vegetation establishment.

b. Fargo shall be responsible for future pond maintenance, including but not limited to sediment removal, inspection, and bank sloughing repair.

4. Park District General Maintenance. Park District shall be responsible for the construction, repair and maintenance of all amenities , including grass mowing, weed treatment, tree trimming, as well as pavement maintenance and repair, and snow and debris removal, as necessary. Park District understands and agrees that it may not construct any amenities on the Pond Property, unless otherwise agreed to in writing signed by both parties, and that Fargo approval will not be unreasonably withheld. Fargo and Park District understand and agree that any work to be completed pursuant to this Agreement that may disrupt Park District use of the property shall be coordinated between the parties so as to minimize impacts, to the extent possible.

a. Park District understands and agrees that any work completed by Park District may not impact the City storm sewer system or change the retention pond level, without prior written consent of City.

b. Fargo agrees Park District shall have some discretion in its use of the property to the extent that any construction activities must first be approved by Fargo, and this Agreement included in writing, as necessary to detail the parties' responsibilities with respect to the Park District constructed amenities.

5. Joint Responsibilities and Coordination. Fargo and Park District agree that collaboration and coordination between the two entities is a necessary component of the successful

operation of the Pond Parcel as a Park District amenity. To the extent possible, Fargo and Park District agree as follows:

- a) The parties agree to jointly seek an Audubon Society agreement to further enhance the use of the Pond Parcel and amenities.
- b) Fargo agrees to assist the Park District, as appropriate, to secure funding for the construction of shared use paths and trails throughout the Pond Parcel.
- c) Fargo and Park District agree to coordinate timing of any work or construction to be done in accordance with the terms of this Agreement so as to not disrupt Park District programming of the Pond Parcel.

6. Signage and Lighting. Fargo and Park District agree and understand that Fargo shall be responsible for signage pertaining to the retention pond. At its discretion, with City approval, Park District may place additional signage on the Pond Parcel relating to approved programming of the space. Further, Park District may be permitted to install appropriate lighting on the Pond Parcel as an amenity of the Park District, provided such installation is solely at Park District cost, and with City advance written approval so as to ensure the lighting will not be impacted by the varying pool levels of the storm water retention pond following a large rain event.

7. Insurance. Both parties understand and agree that it shall secure the necessary insurance for the proposed use of the Pond Parcel.

8. Dispute Resolution.

- a. Fargo and the Park District will each designate a representative who will be the party's representative with respect to any matters relating to the repair and/or maintenance of the improvements and amenities identified herein, which may be in dispute or requiring agreement under the terms of this Agreement. Such representative may be changed from time to time. The representatives will be responsible for resolving any dispute between the parties concerning this Agreement and for the preparing an annual schedule of maintenance and repairs.
- b. If the designated representatives cannot agree with respect to any matter requiring agreement or with respect to any dispute concerning this Agreement, the parties will submit the matter to their respective Boards (or a committee established by the Board) to resolve the dispute.

9. Option/Right of First Refusal. Fargo and Park District understand and agree that the property acquired by Fargo for the purpose of the storm water retention pond may result in a remnant of approximately 80 acres, more or less, as shown in Exhibit "B" attached hereto ("Remnant Parcel").

- a. City agrees to dedicate up to 8% of the Remnant Parcel to the Park District for park purposes, such dedication to be adjacent to the Pond Parcel and in a location mutually

acceptable to City and Park District, at City's final discretion. To the extent the full 8% is dedicated to the Park District by City pursuant to this Agreement, the parties understand and agree that there shall be no further dedication responsibility with respect to the sale and development of the Remnant Parcel.

b. City further hereby grants Park District an Option/Right of First Refusal to acquire the Remnant Parcel, or any part thereof, at a time City determines appropriate. Fargo shall first offer the Remnant Property to Park District for a price to be determined by appraisal, in the following manner.

(i) Fargo shall give Park District written notice of the decision to sell, delivered by certified mail, return receipt requested.

(ii) Park District shall notify Fargo of its intent to buy the Remnant Parcel, or any part thereof, for the appraised price within 60 days of receipt of notice. Failure to provide written timely notice of intent to purchase/sell be considered a rejection of the offer upon payment of agreed price upon acceptance.

(iii) Fargo shall deed to Park District by Quit Claim Deed the acquired portion of the Remnant Parcel, subject to all easements and encumbrances of record.

(iv) Park District shall secure possession of the acquired portion of the Remnant Parcel upon deed conveyance.

10. Minnkota Power Company Easement. Fargo and Park District understand and agree that a portion of the Pond Parcel is encumbered by an easement to Minnkota Power Company, and Fargo and Park District further recognize and agree that any amenities permitted by this Agreement may not hind, impair or impede Minnkota Power's use of the easement property.

11. Term. The term of this Agreement will be 20 years. This Agreement will automatically renew for successive periods of 20 years. If either party intends to terminate this Agreement at any time, at least 180 days' Notice shall be given to the other party. This Agreement is personal as to the Park District, and may not be assigned or transferred without Fargo written consent.

12. Release and Waiver. In consideration of the mutual promises of the parties and to the fullest extent permitted by law, each party assumes all risk of personal injury or death and property damage or loss from whatever causes arising while that party, its agents, employees or designees are conducting work pursuant to this MOU and each party releases the other party, its officers, employees, agents or designees relating to or arising out of that parties', agents, employees or designees work pursuant to this MOU, whether known or unknown, foreseen or unforeseen, liquidated, unliquidated, fixed, contingent, material or immaterial, disputed or undisputed, suspected or unsuspected, direct or indirect, at law or in equity, from the beginning of time, and each party understands and acknowledges the significance of such release and waiver and hereby assumes full responsibility for any injuries, damages or losses that it may incur as a result of its execution of this MOU.

13. Notice. Any notice or election required or permitted to be given or served by any party to this MOU upon any other will be deemed given or served in accordance with the provisions of this MOU if said notice or election is (a) delivered personally, or (b) mailed by United States certified mail, return receipt requested, postage prepaid, and in any case properly addressed as follows:

Each such delivered notice or communication will be deemed to have been given upon the delivery. Any party may change its address for service of notice in the manner specified in this MOU.

14. Time is of the Essence. Time is of the essence of each provision of this entire MOU and of all the conditions thereof.

15. Entire Agreement. This MOU constitutes the entire and complete agreement between the parties and supersedes any prior oral or written agreements between the parties. It is expressly agreed that there are no verbal understandings or agreements which in any way change the terms, covenants and conditions set forth herein, and that no modification of this MOU and no waiver of any of its terms and conditions will be effective unless in writing and duly executed by the parties. It does not negate the parties' rights, duties and obligations under prior agreements/easements related to the floodwall, storm sewer construction and operation, and maintenance of the floodwall and storm sewer.

16. Amendments. No amendment, modification, or waiver of any condition, provision or term will be valid or of any effect unless made in writing signed by the party or parties to be bound, or a duly authorized representative, and specifying with particularity the extent and nature of such amendment, modification or waiver.

17. No Forbearance. The failure or delay of any party to insist on the performance of any of the terms of this MOU, or the waiver of any breach of any of the terms of this MOU, will not be construed as a waiver of those terms, and those terms will continue and remain in full force and effect as if no forbearance or waiver had occurred and will not affect the validity of this MOU, or the right to enforce each and every term of this MOU.

18. Remedies. Except as expressly and specifically stated otherwise, nothing herein will limit the remedies and rights of the parties under and pursuant to this MOU.

19. Binding Effect. All covenants, agreements, warranties and provisions of this MOU will be binding upon and inure to the benefit of the parties and their respective representatives, successors and assigns.

20. Governing Law. This MOU has been made and entered into under the laws of the State of North Dakota, and said laws will control its interpretation. Any litigation arising out of this MOU will be venued in State District Court in Cass County, North Dakota, and the parties waive any objection to venue or personal jurisdiction.

21. Rules of Construction. The parties acknowledge that they have had the opportunity to review this MOU, and that they have an equal bargaining position in this transaction. No rule of construction that would cause any ambiguity in any provision to be construed against the drafter of this document will be operative against any party to this MOU.

22. Representation. The parties, having been represented by counsel or having waived the right to counsel, have carefully read and understand the contents of this MOU, and agree they have not been influenced by any representations or statements made by any other parties.

23. Headings. Headings in this MOU are for convenience only and will not be used to interpret or construe its provisions.

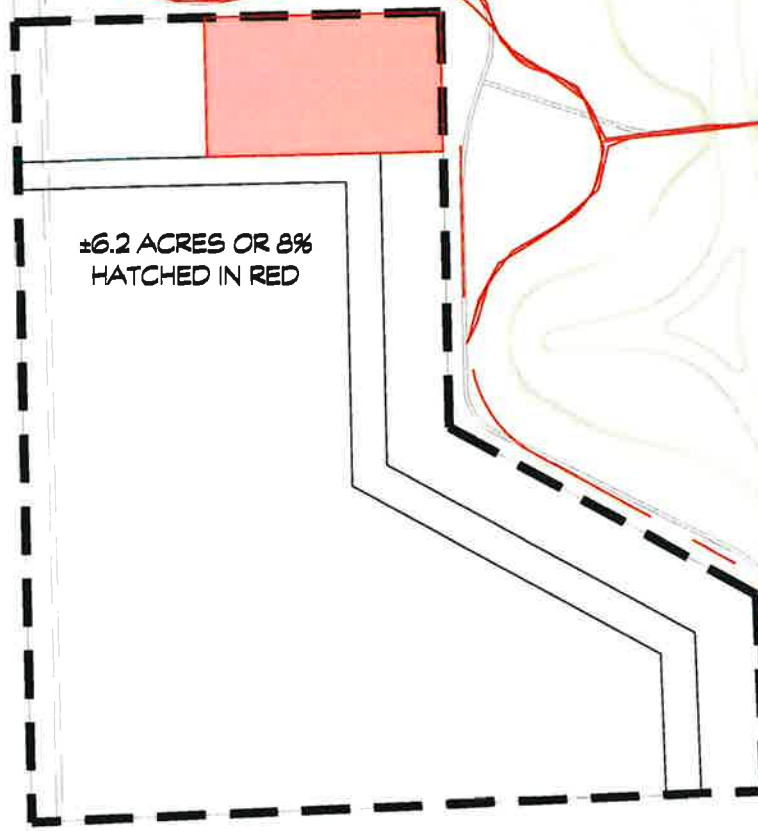

RE: Agenda Item No. 4 – 2027 Preliminary Budget Update

The 2027 budget process kicked off at the end of April with district-wide presentations setting up expectations, goals, cost recovery targets, and the budget timeline, which we have previously shared with the Planning Committee and the full board. Seventy-five employees throughout the district participated in the presentations, helping to raise a broader understanding of budget development.

This year's process also included the implementation of new budget software. The new Euna software will allow for additional reporting, budget monitoring, and ease of data upload. Individual department budget meetings included training on the new software. Feedback to date has been positive as the software is very user friendly.

Today we present to you a balanced 2027 preliminary budget for your review. The 2027 budget includes:

The 2027 budget includes the following details regarding both revenue and expenses:

Revenues

Property Tax: (52% of General Fund) Fargo remains a growth city and the legislation pertaining to property tax caps allows for a 3% increase plus new growth. To capture all the allowable growth in the general fund, staff recommends a reduction of the Debt Service levy of .38 mills (10.07 – 9.69), and a corresponding increase to the General Fund levy of .38 mills (21.16 – 21.54), resulting in \$1.1 million dollars in new tax income in 2027. Further, staff recommends an additional reduction in the Debt Service levy of .20 mills (9.69 – 9.49), still allowing the district to cover all debt obligations associated with bonds and special assessments. The staff recommendation is based on the ability to capture the maximum general fund flexibility, meet all debt obligations, and reduce overall property taxes to the citizens of Fargo.

Charge for Services: (35% of General Fund) Each department which charges for services throughout the park district did a thorough analysis of fees related to demand, comparable charges at peer organizations, cost recovery targets, historical pricing, operational challenges, and market/program trends. Departments presented fee recommendations to the district planning committee and the full board for approval. One main change to charge for services in 2027 is the introduction of resident/non-resident pricing for season golf passes and season pool passes. The budgeted new revenue for charge for services in 2027 is \$727,377, for a total of \$15,425,804 district wide.

Intergovernmental Revenue: (9% of General Fund) Collaborating with the City of Fargo, we have budgeted no increase in state aid for 2027, total anticipated collection is \$4.325 million.

Interest Income: (2% of General Fund) Completion of capital projects in 2025 has reduced cash reserves as anticipated and annual interest income is leveling out at a more normalized level. The 2027 budget includes \$937,500 in interest income.

Sponsorship/Donations/Foundation Support: (1% of General Fund) Annually, the park district receives several sponsorships, and we also are recognizing foundation pledges more than pledge loan payments. The 2027 budget includes \$528,615 (\$278,615 in the General Fund and \$250,483 in the Capital Projects Fund) of revenue from these sources.

Expenses

Compensation: (37% of General Fund) The recommendation for full-time compensation increase is 4.5%. Further, the budget contains \$125,000 for market adjustments based on the latest market analysis. Total increase in employee compensation for 2027 is \$456,686 compared to the 2026 budget.

Employee Benefits: (13% of General Fund) Working with Gallegher & Associates to review all lines of insurance and review offerings, which include a second option for a high-deductible health plan in the current fiscal year, the 2027 budget includes a 10% in employee benefits that are not directly tied to wages, and a 6% increase for those tied to wages. Total for employee benefits in 2027 is \$5,531,085, an increase of \$322,679.

Program & Operational Costs: (17% of General Fund) This category includes all programs offered through the recreation department, events, and all operational costs associated with daily operations of the district. Total costs in 2027 are \$7,739,702 an increase of \$153,590.

Repair & Maintenance: (6% of General Fund) Annual maintenance throughout the district separate from the Capital Improvement Plan (CIP) in 2027 total \$2,692,864 and increase of \$295,677.

Utilities: (5.5% of General Fund) Collaborating with our partners at Cass County Electric and Excel Energy, we have built in a 3% increase in utility costs for 2027 for a total of \$2,439,073, an increase of (\$284,631) compared to 2026 budget.

Capital Equipment & Improvements: These items were reported on a single line item in the 2026 and have been broken apart for 2027. There is a total reduction in these areas of (\$212,093) compared to 2026 budget.

Capital Equipment: (8% of General Fund) District wide equipment purchases for 2027 total \$3,518,142.

Capital Improvement: (9% of General Fund) Additional maintenance and district wide improvements to facilities and property in 2027 total \$3,777,065.

Transfers Out: Annually, the district budgets transfers to fund the CIP. In 2027 we have budgeted \$2,199,704, which is \$1,949,704 from the administration department and \$250,000 from golf department to the capital projects fund. These transfers will help fund project outlays in the capital projects fund.

Debt Service Fund

The 2027 debt service fund is balanced with Revenue and Expenses totaling \$9,327,597. This is a reduction of \$937,699 from the 2026 budget. Absent taking on additional debt or special assessments on property, this trend will continue as annual debt payments are made. The mill levy tied directly to general obligation bonds is required to decrease as debt payments are made, as we are only able to levy for the actual dollars needed to make the annual payments. If Fargo remains a growth market, the district will see a natural reduction in debt service levy annually.

Strategically, the district can capture growth in the general fund while the debt service fund decreases, providing flexibility in annual operations while maintaining a flat tax rate or a slight decrease to the overall mill levy, and complying with the legislative mill levy cap.

Valley Senior Services

The 2027 Valley Senior Services budget is balanced with Revenue and Expenses totaling \$8,072,475 for all counties we serve. This is an increase of \$567,266 over the 2026 budget.

Valley Senior Services is funded by mainly by Federal and State (Intergovernmental) grants for the nutrition and transit purposes, which make up 57% of its total budget. The other main source of revenue is funding from each county in our service area, in which those counties have dedicated property tax mill levy dollars to support senior services. These tax dollars make up 27% of the VSS budget.

Full Time, Part Time and Employee Benefits make up a total of 51.6% of the VSS budget. These three line items total \$4,166,558 in the 2027 budget which is an increase of \$266,885 from the 2026 budget.

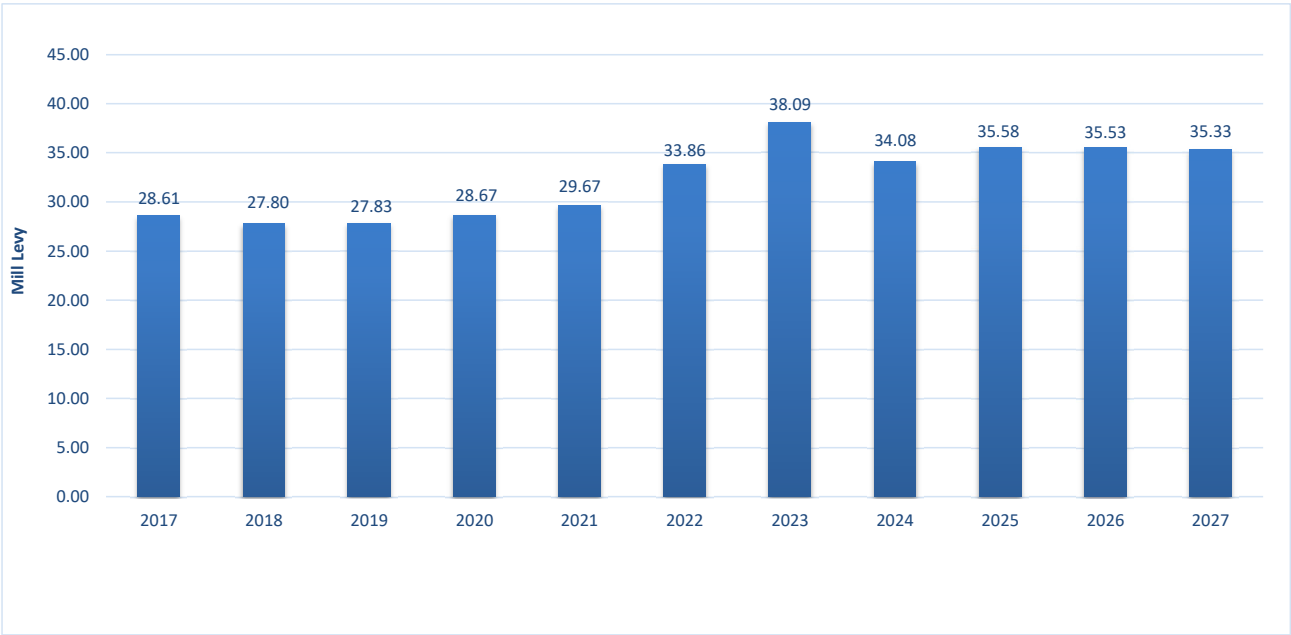

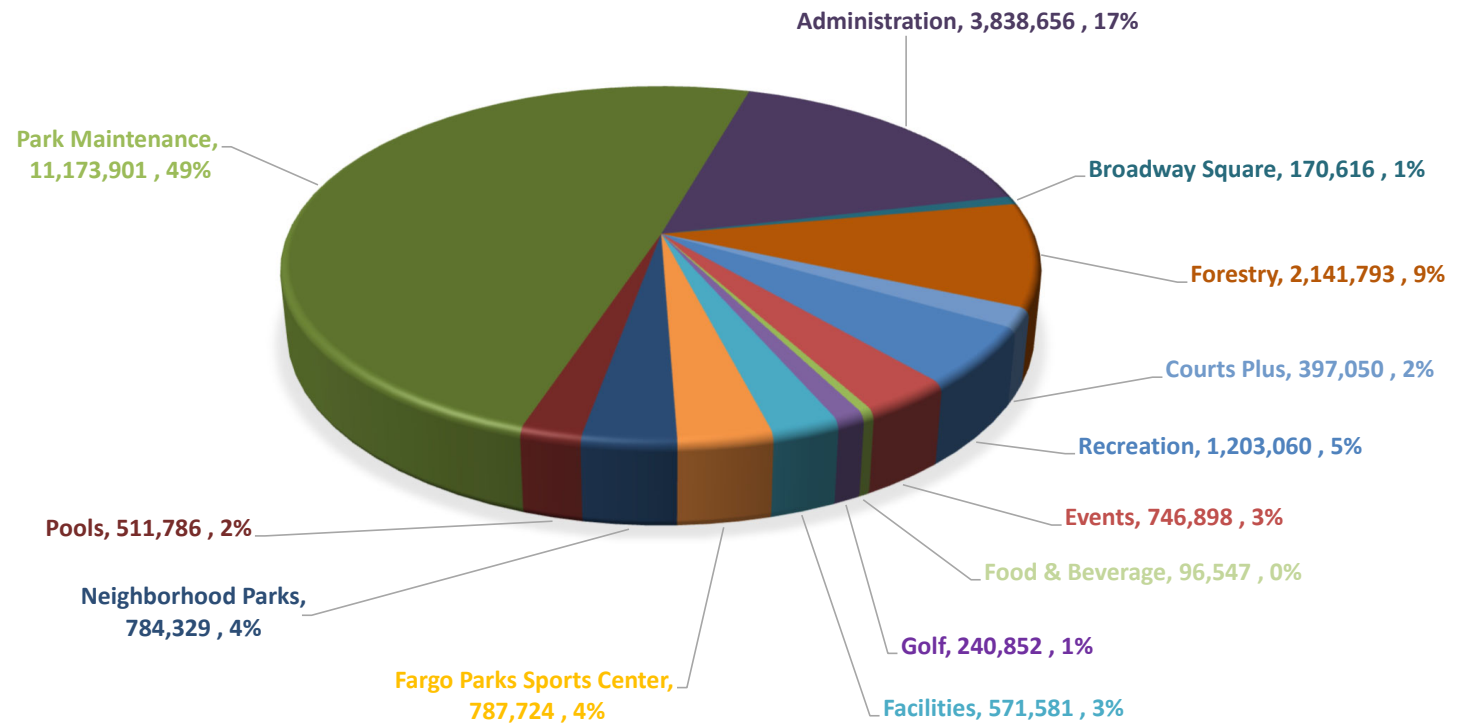

E-BIKES & E-SCOOTERS

WHERE CAN YOU RIDE IN FARGO?

E-BIKES (NDCC 39-10.1)

An electric bicycle is a bicycle with operable pedals, a seat and an electric motor of 750 watts or less.



WHERE CAN YOU RIDE

Allowed
- ✓ **BIKE LANES & BIKE PATHS**
Allowed
- ✓ **SIDEWALKS & MULTI-USE PATHS***
Allowed unless posted otherwise

E-bike riders must follow all traffic laws and rules of the roadway or be subject to citations.

MOTORIZED SCOOTERS (<15 MPH) (FARGO ORDINANCE 8-20)

Applies to motorized scooters (not used for mobility impairment) that cannot exceed 15 mph.

Commissioner Rostad, presented

 - Planning Committee aligned to 8:00 a.m. as well, for consistency and to avoid confusion with close start times.
 - Change to begin with September meetings; staff will update calendar invites and published schedules.

The committee recommends moving this to the full board and placing it on the Consent Agenda for consideration and approval.

Review and Discuss Governance Policies
Commissioner Rostad, presented

- Policies reviewed:
 - GP1 – Commitments
 - GP3 – Duties and Responsibilities
 - GP4 – Officer Roles
 - GP7 – Commissioner Code of Ethics
- No changes were proposed; policies proceed as-is.
- Next steps:
 - Staff to send out monitoring forms (via SharePoint) to commissioners.
 - Each commissioner will indicate compliance/non-compliance and provide comments.
 - Completed forms will be collected and summarized for reporting back.

Discussion of E-bikes and E-Scooters
Commissioner Rostad, presented

- Local news stories about kids injured on e-bikes.
- West Fargo School District banning certain devices at elementary and middle schools.
- Observations of widespread youth use of e-bikes/e-scooters in parks and near schools.

- Board/committee concern:
 - Safety (speed, quiet approach, mixed use with walkers and pets).
 - Clarity on what's allowed on trails.
 - Realistic enforcement limits.

Current Approach

- Park District coordinated with:
 - Fargo Police Department.
 - City of Fargo.
 - Fargo Public Schools leadership.
- Key tools in place:
 - New park ordinances aligned with city, giving police authority to enforce e-bike/e-scooter rules in parks and on trails.
 - Shared educational flyer (from Fargo PD) explaining:
 - What is a pedal bike vs. e-bike vs. other motorized devices.
 - Which are legally allowed on trails and under what conditions.
 - Park District has posted the same guidance via social media as an education campaign.

Enforcement Challenges

- Park staff are not deployed along trails all day; enforcement is largely dependent on law enforcement.
- Public feedback often focuses on “How will this be enforced?” which remains the main constraint.
- Signage:
 - New, detailed signage is considered problematic:
 - Expensive and permanent in an area where laws and devices are rapidly evolving.
 - Difficult to capture nuanced legal distinctions and future changes.
 - Committee leaned toward education and courtesy campaigns over extensive new signage.

Possible Future Directions

- Broader education/courtesy focus:
 - General trail etiquette: bikes vs. walkers, passing etiquette, dogs on trails, headphones, etc.
 - Framed as “Using Park Paths & Trails Safely and Courteously,” not as a crackdown on scooters.
- Legislative strategy:
 - Suggestion to raise the e-bike/e-scooter issue with NDRPA and other park districts statewide for possible state-level legislative priorities.
- Youth engagement:
 - Idea to involve Fargo Youth Initiative and students in co-creating and promoting a public education campaign (especially since youth are major users).
- Coordination with schools:
 - Staff will follow up with Fargo Public Schools about any further measures related to e-bikes/e-scooters on school property.
 - Emphasis on aligning messaging and using school resource officers where feasible.

Snow Removal Bids at the Fargo Parks Sports Center
Kali Mork, presenter

- Bids received from four companies for snow removal at Fargo Parks Sports Center
- Staff recommend a 3-year contract with Glacier Snow:
 - Prior positive performance and familiarity with the site.
 - Competitive monthly rate lower than current contractor.

The committee recommends moving this to the full board and placing it on the Consent Agenda for consideration and approval.

Consideration of Amendment to the Southwest regional Pond Memorandum of Understanding with the City of Fargo
Tony Schmitt, presenter

- Proposal to amend the existing 2019 MOU to:
 - Add the Far South Pond (south of 64th Ave S) to the agreement.
 - Clarify future responsibilities for shared-use paths and box culverts, especially at replacement time (25–30+ years out).
- Key points:
 - North Pond: Park District already obligated to install trails there; significant costs (full trail build-out originally over \$4M).
 - South Pond: Intent is shared funding via adjacent development and special assessments rather than solely Park District dollars.
 - Partnership with Audubon (Great Plains) providing funding for native grass establishment.
- Board concerns:
 - Current language relies on “cooperate/coordinate” and feels too soft; request to strengthen commitments so future city leadership is more clearly tied to replacement cost sharing.
 - Need to avoid a situation where Fargo Parks is “holding the asset” without clear long-term city cost participation.

The committee recommends moving this to the full board and placing it on the Regular Agenda for consideration and approval.

2026 Market Compensation Review and Recommendation 2027 Compensation Adjustments

Kelsey Smith, presenter

- HR completed a market compensation review of 95 full-time positions using regional public-sector comparators.
- Findings:
 - 42 positions: <5% range change.
 - 33 positions: 5–9% range increase.
 - 20 positions: 10%+ increase needed (notably park maintenance roles).
- 2027 recommendation:
 - 4.5% combined increase:
 - 1% across-the-board.
 - 3.5% merit pool, using a merit matrix tied to performance and position-in-range.
 - Additional \$125,000 equity pool for 43 employees needing targeted market adjustments.
- Other workforce items:
 - Total full-time employees: 169.
 - Plan to provide annual total compensation statements (salary + benefits + retirement + “soft” benefits).
 - Align part-time pay ranges with full-time structures; part-time will also benefit from updated ranges.
 - Education plan: department meetings to explain market adjustments, merit process, and performance expectations.

2027 Budget Review

Broc Lietz and Luke Evenson, presenters

- Total all funds: about \$64.28M (General, Valley Senior Services, Capital Projects, Debt Service).
- General Fund – Revenues
 - Property tax: 52% of General Fund.
 - Strategy: use full 3% cap + new growth; shift 0.38 mills from Debt Service to General Fund to capture capacity.
 - Staff recommendation to reduce Debt Service by an additional 0.2 mills, dropping total from 35.53 to 35.33 mills overall.
 - Charges for services: 35%; projected +\$727K in 2027 (golf, pools, programs, Courts Plus, facility use, etc.).
 - Intergovernmental (state aid via city): 9%; assumed flat based on city guidance.
 - Interest income: 2%; projected \$937K, moderating as large project cash balances decline.
 - Sponsorships/donations/foundation: 1%; includes foundation pledge reimbursements from the capital campaign (about \$7M total over time) coming back to the general fund with no new donor restrictions.
- General Fund – Expenses
 - Compensation: 37% of General Fund.

- Benefits: 13%; currently budgeted at +10% increase pending broker update.
- Programs & operations: 17%.
- Repair & maintenance: \$2.6M.
- Utilities: 5.5%, trending down slightly (efficiencies, especially in the new building).
- Capital equipment: 8%.
- Capital improvements: 9%.
- Transfers out to CIP: \$2.2M (about \$1.9M from Admin + \$250K from golf capital).
- Structural transparency changes:
 - Benefits currently all sit in Admin; plan to allocate benefits to departments so true costs show per function.
 - Internal transfers and admin-heavy items will be clarified so the 29% admin share reflects reality after shifting those costs.
 - Debt Service Fund will be split and reported as:
 - Bond debt service (no flexibility, G.O. bonds).
 - Special assessment debt (more flexible, may be prepaid).
- Capital Projects – 2027
 - Four recommended projects (approx. \$3M+ total):
 - Edgewood Irrigation Phase 1 (including pump station; part of a two-year 2027–28 project).
 - Jack Williams Stadium lights.
 - Southwest Regional Pond – Phase 1 (natural surface trails, erosion control, native seeding, supported by Outdoor Heritage Fund).
 - Tharaldson Little League turf (Park District share).
- Valley Senior Services (VSS)
 - 2027 budget about \$8M (up \$0.5M from 2026).
 - Funded via county levies (up to 1 mill per county) + state and federal sources; no direct General Fund dollars, but significant shared admin support.
 - VSS reserves currently near 100% of annual budget; staff will:
 - Revisit reserve targets (likely higher than Parks' 25% due to federal/state funding risk).
 - Clarify how much of reserves can/should go toward facilities vs. operations.
 - Tighten documentation (e.g., county forms) so representation of “new senior center” dollars is realistic and consistent.

The committee recommends moving this to the full board and placing it on the Regular Agenda for consideration and approval.
